This consent form is designed to give you the information you need to make an informed decision about whether or not to undergo treatment with Hyaluronic Acid Dermal Filler for facial wrinkles and folds, contour defects, and/or lip enhancement

INTRODUCTION

Hyaluronic Acid treatment uses air pressure of purified Hyaluronic Acid into the skin to fill wrinkles and restore volume. No skin testing is needed prior to treatment. Just like natural Hyaluronic Acid, injectable Hyaluronic Acid eventually loses its form and wears down. The effects of the Hyaluronic Acid can last 6 months or longer and ongoing treatments are required to maintain the improvements. However, due to various factors that influence Hyaluronic Acid breakdown, no guarantees can be made regarding how long correction will last in a specific patient

PATIENTS THAT MAY NOT BE ELIGIBLE FOR HYALURONIC ACID TREATMENT

Patients with the following conditions may not receive Hyaluronic Acid treatments: previous allergic reactions to injectable hyaluronic products, history of a serious allergic reaction (anaphylactic), multiple severe allergies, abnormal raised scarring or keloid formation, active inflammation, infection in the treatment area (e.g. pimples, rash, hives), pregnancy, or nursing or recent dental/facial surgery. Individuals who have recurrent viral infections such as herpes simplex (cold sores) as it may be activated by Hyaluronic treatments. Your Service Provider must be notified of these conditions prior to treatments

POSSIBLE RISKS

The possible risks, side effects, and complications with Hyaluronic Acid include, but are not limited to (please read each statement and initial in each box to accept your acknowledgement and agreement to the following risks):

Pain and tenderness during and after treatments at/around the treated site that typically resolves within a few days to a week.

Infection at the treated site. This may require antibiotics and, rarely, open drainage. Although rare, local tissue damage can occur with skin breakdown, scab formation, and/or scarring in the treated area.

Nano Shape of Beauty

Redness and swelling at/around the treatment site is common. Itchiness may also occur. These reactions are generally present immediately after treatment and lessen or disappear within a few days to 1 week. Some patients may experience prolonged swelling and/or tenderness/pain at the treatment site lasting up to 2 weeks. Some patients may experience a delayed onset of these symptoms up to several weeks after treatment. On rare occasions, pustules (acne-like lesions) may form. The Service Provider must be notified if symptoms persist for more than 1 week. Bruising which usually resolves within 1-2 weeks after the treatment. Patients taking medications that interfere with coagulation (e.g. aspirin, ibuprofen) have an increased risk of bruising and bleeding.

Visible raised areas and lumpiness at/around the treated site grayish discoloration of the skin. These symptoms may persist from a few weeks to several months and may be permanent (rarely). Failure to reduce a contour defect or wrinkle (under correction) or overcorrection. Placement of filler adjacent to or outside the desired treatment area; undesired changes in facial contour. Asymmetry, where the correction on one side may be different from the correction on the other side of the face. Swelling at time of injection may create the appearance of asymmetry or under correction with usually resolves as described above. However, you may need to return for additional treatment if under correction or asymmetry persists.

Hyaluronic Acid may have an unpredictable duration of action and may not last as long as anticipated or may persist in some areas longer than anticipated.

All the risks of Hyaluronic Acid may not be known. My service provider and business are not responsible for any Hyaluronic Acid risk or unforeseen complication not yet discovered or not commonly known. If the filler is injected into a vessel, it can occlude the vessel therefore blocking circulation - in very rare occasions if the filler is injected into the retinal artery and/or travels into the ophthalmic artery it can cause blindness (partial, or total).

No guarantees can be made or have been made that I will benefit from treatment or achieve a desired level of correction. There is no guarantee wrinkles or folds will be reduced. I understand that I may require additional treatments to achieve correction. I understand that the fees for hyaluronic acid treatments are not covered by insurance. Should I require a touch-up treatment, I am responsible for the cost of any additional treatment(s).

I consent to having my photos taken before and after treatment. These photos are part of my medical record.

I have fully disclosed all my medical history. I understand that it is my responsibility to inform and update my service provider of any change in my health status and medical history.

HYALURON PEN FILLER - FREQUENTLY ASKED QUESTIONS

What is hyaluron pen?

A newcomer in the beauty industry, the Hyaluron Acid Pen is just a device for transferring liquid and has actually been around for a few decades but with a very different use, inserting Insulin in the skin for Diabetics. After scientific experiments, this device was used to shoot Hyaluronic Acid into the lips and face without the need for a needle. This is ideal for people that are frightened or uncomfortable with needles, this pain free treatment is less invasive, fast and allows you to have plump, natural looking lips and reduce fine lines and wrinkles.

How does it work?

The pen uses air pressure that is strong enough to deliver a liquid mixture of Hyaluronic Acid in miniscule molecules through the skin. Perfect for lip enhancements and reducing wrinkles. The Hyaluronic Acid only reaches the dermis (upper layer of skin) making this a safe treatment with no risk of blockage to blood vessels since the pen doesn't have a sharp tip to puncture them. Not to mention, filler with a needle can be very painful and cause trauma to the skin that can actually result in scar tissue. The Hyaluronic Acid used is not permanent although it is a buildable procedure that enables you to achieve your desired look. As the procedure is non invasive, the risk of bruising and swelling is also extremely low unlike fillers using injections.

What is hyaluronic acid?

Hyaluronic Acid is the main structural element of connective tissue and a natural sugar found in the human body. It is the most hydrating substance in the world and loves to bind with water molecules, often being able to bind up to hundreds of times its own weight, hence its function is to attract water and keep skin hydrated, plump and youthful. Unfortunately, the ability to be able to retain water decreases over time as we age and the collagen fibres dry up and become thinner, resulting in loss of hydration and elasticity. This causes the skin to loosen and the formation of wrinkles. By adding Hyaluronic Acid into the skin we revive the collagen, providing hydration, rejuvenating the skin and promoting a fresher, more youthful look. The human body creates Hyaluronic Acid naturally so it is impossible to be allergic to it. Additionally, the "cross-linking" process of the Hyaluronic Acid gives longevity to the substance, typically 3 to 7 months unlike the Hyaluronic Acid we produce naturally which typically only has a life span of 2 to 4 days. In any case, whatever filler a therapist may use, you don't want it to stay inside the skin forever, so the fact you need to have a refill every 4 to 6 months or so to keep your desired look is a good thing.

Why haven't I heard about this procedure before and is it safe?

The technology is nothing new in the device itself as it's been used for inserting insulin for years. However, since 2018 it has been used as a beauty tool to fill wrinkles and lips. Problems with injections come from blocked blood vessels to which a filler has been injected. With the Hyaluronic Pen, it is impossible to inject a substance, thus there is no such risk and is totally safe. Thousands of people are using it all over the world. In a way, it is a simple moisturiser to the upper layer of skin (dermis) that can also be used to enhance the shape and thickness of lips and reduce wrinkles. The real difference between a potential disaster and an excellent result are the skills of the therapist to shape the lips in a natural and beautiful way and the quality of the filler.

Is the hyaluron pen suitable for everyone?

All potential clients are required to complete a health questionnaire to assess compatibility for Hyaluronic Acid Pen treatment. The procedure most definitely can not be done to pregnant women. The Hyaluronic Acid we use contains Lidocaine so anyone that suffers from an allergy to this substance would also not be suitable for treatment
